CALL TO ORDER: Council Member Villalta called the Adjourned City Council / Redevelopment Agency Meeting to order at the hour of 4:39 p.m.

PLEDGE OF ALLEGIANCE. The pledge of allegiance was recited.

CONSIDERATION OF APPROVAL OF AGENDA: Motion by Stone, seconded by Faria to approve the agenda as submitted. The motion carried by the affirmative action of all City Council Members present, Sousa and Jones absent.
