SPECIFICATIONS:

ONE (1) NEW 2020 HEAVY DUTY FORD POLICE INTERCEPTOR UTILITY AWD SUV K8A

The following specifications are minimum unless otherwise specified:

THIS VEHICLE WILL BE USED AS AN UNMARKED POLICE VEHICLE

Model:

2020, new four door heavy duty Ford Police Interceptor Utility all-wheel-drive sports utility vehicle equipped with the manufacturer's heavy duty police package including, but not limited to the following heavy duty equipment:

Engine:

1. Minimum, 3.3L V6 direct injection flex fuel gasoline.
2. Heavy duty cooling package.
3. High output alternator.
4. Engine oil cooler.
5. High performance drive belts.
6. Heavy duty battery compatible with charging system.

Transmission:

1. Automatic transmission.
2. Oil cooler.
3. Column-mounted shifter.

Brakes:

1. Power 4-wheel anti lock brake system.
2. Heavy duty police package pads and rotors.

Suspension/Chassis:

The front and rear suspension, including shock absorbers, shall be heavy duty, and designed for police patrol vehicle use.

Tires and Wheels:

Factory installed five (5) heavy duty steel speed rated tires to be trued and balanced before delivery. Standard black wheels with center cap.

Interior:

1. Cloth Front Bucket Seats, second row cloth seats.
2. Power driver seat.
3. No carpet, heavy duty black vinyl floor covering.
4. Standard factory installed air bags.
5. Tilt or telescope steering column.

6. Center console mounting plate
7. Rear view camera display

Exterior:

1. Factory applied exterior color, **BLUE METALIC PAINT.**
2. No spot lights.
3. No ballistic door panels.
4. Driver door keyless entry keypad.

Manufacturer's Warranty:

Standard warranty, 5 year/100,000 mile power train warranty.

Miscellaneous:

Minimum specifications for equipment; vehicle may have more equipment. Vehicle shall contain all equipment-catalogued as standard by the manufacturer and if not considered standard the bidder prior to delivery shall install the following equipment.

1. Power outside mirrors.
2. Factory installed air conditioning/heater and aux second row air conditioner 88F
3. Power windows.
4. AM/FM blue tooth radio.
5. Power locks, remote key-less entry.
6. Each vehicle shall include minimum five (5) sets of keys/key fobs.
7. Speedometer certified calibration.
8. Cruise control.
9. Standard factory installed privacy glass.
9. DMV California-exempt registration to be completed by successful bidder.
10. No locking gas cap, no wiring preparation package, no rear window power delete, no rear door lock disable.

GENERAL INFORMATION

Bid Quotes:

Bidders shall quote the price of the vehicle on the City of Los Banos Bid Proposal form. Bids not submitted on the Bid Proposal form may be rejected. Bids received after 2 p.m. on the closing date will be returned.

All bidders must submit with their proposal sufficient literature to show compliance with specifications. Any deviations from specifications must be clearly indicated in writing at the time the proposal is submitted. The City reserves the right to waive minor variations in specifications.

The award will be made to the lowest responsible bidder whose bid complies with the specifications in a manner satisfactory to the City's best interests as determined by the City. The right is reserved, as the interest of the City may require, to reject any or all bids, or to waive any informality or minor irregularity in the bids.

Bids shall include California sales tax but exclude Federal Excise sales tax; shall include delivery charges; shall include California Tire Recycling Fee; shall include DMV document preparation fee for exempt license plates.

Local Business Preference:

In evaluating competitive bids, the City shall determine the lowest responsible bidder, and any local Los Banos bidder shall be granted a preference in an amount equal to five (5%) percent of the lowest responsible bid, if that low bid has been submitted by a non-local bidder. If, after deduction of the five (5%) percent preference from a local bidder's bid, it is equal to or less than the lowest bid, the bid shall be awarded to the local bidder.

To qualify as a local bidder, firms or individuals must submit written proof of the address of their principal place of business and a copy of their current City business license with each bid for which a preference is claimed. Proof of address is normally the address to which contract and payments will be sent.

Local preference only applies to supplies, materials and/or equipment, and will not apply to bids conducted with other public agencies nor when prohibited by State or Federal statutes or regulations to be awarded to the lowest responsible bidder, or otherwise exempted from local preferences. A total amount of such a preference granted in a single bid shall not exceed Five Thousand and No/100ths (\$5,000.00) Dollars over a non-local bidder.

Additional Optional Equipment:

After award, the City may request additional equipment options to be priced separately from the bid amount.

Delivery Date:

Bids shall include a specific maximum date of delivery, example: 60 days from the date the bid is awarded by the City Council. In the event the new vehicles have not arrived at the successful bidder's place of business by the first Council Meeting following the successful bidder's delivery date as listed on the official bid form, the contract between the successful bidder and the City may be considered null and void.

Extension of Delivery Date:

The City Council shall have the option of granting an extension to the successful bidder provided he/she has submitted a written request identifying the reason the extension is necessary to the City Council prior to the first meeting following the delivery date shown on the official bid form.

Accepting Secondary Bid:

In the event a successful bidder fails to provide the vehicle within the time specified and the contract is canceled, the City may enter into an agreement with the next lowest bidder for delivery of the vehicle.

Delivery of Vehicles:

Vehicles shall be delivered to the Los Banos Police Department, 945 5th Street. Los Banos CA. 93635. The vehicles shall be completely serviced as recommended by the manufacturer prior to delivery to the City, and shall be delivered to the City with a **full tank of fuel**. Title to vehicles shall not pass to City until the units have been delivered to the designated location and have been inspected and accepted by the City.
